### **2. Consider Non-Exclusive Grant and Assignment of Easements**

This is Phase 3 platting requirements, which is consistent with Phases 1 & 2.

A **motion** was made by Ms. Ray, seconded by Ms. Robertson and passed unanimously approving the Non-exclusive Grant and Assignment of Easements, as presented.

### **3. Consider Special Warranty Deed**

This is similar with the Phases 1 & 2 real property and is transferred with assets.

A **motion** was made by Mr. Brooks seconded by Ms. Ray and passed unanimously approving the Special Warranty Deed, as presented.

### **4. Consider Resolution No. 2025-13 – Ratifying Sale of Series 2025 Bonds**

Ms. Willson presented Resolution No. 2025-13, entitled:

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE DEL WEBB OAK CREEK COMMUNITY DEVELOPMENT DISTRICT RATIFYING, CONFIRMING, AND APPROVING THE SALE OF THE DEL WEBB OAK CREEK COMMUNITY DEVELOPMENT DISTRICT SPECIAL ASSESSMENT BONDS, SERIES 2025 (2025 PROJECT AREA); RATIFYING, CONFIRMING, AND APPROVING THE ACTIONS OF THE CHAIRMAN, VICE CHAIRMAN, TREASURER, SECRETARY, ASSISTANT SECRETARIES, AND ALL DISTRICT STAFF REGARDING THE SALE AND CLOSING OF THE DEL WEBB OAK CREEK COMMUNITY DEVELOPMENT DISTRICT SPECIAL ASSESSMENT BONDS, SERIES 2025 (2025 PROJECT AREA); DETERMINING SUCH ACTIONS AS BEING IN ACCORDANCE WITH THE AUTHORIZATION GRANTED BY THE BOARD; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

Ms. Willson advised that this resolution ratifies all actions taken and ancillary documents for the bond issuance.

A **motion** was made by Ms. Ray, seconded by Ms. Robertson and passed unanimously adopting Resolution No. 2025-13, as presented.

### **5. Discussion Regarding Lake Banks**

The Lake Banks Inspection Report will be presented in February. The HOA and residents have requested a Q&A/Presentation regarding the Water Management System. The District Engineer will coordinate with the HOA and schedule this event. This will not be an advertised Workshop so only one District Board Member may attend.
